## MARYLAND RESPONDS WINS ANOTHER NATIONAL AWARD



Maryland Responds was awarded a Silver Award for its newsletters by the 2015 National Public Health Information Coalition (NPHIC) Awards for Excellence in Public Health Communications.

Council members will provide strategic direction to the Maryland Responds MRC Network. Specifically, the goals for this year's council are to:


- Set targets and increase opportunities for volunteer recruitment.

# HIGHLIGHTS FROM THE FIELD

## CECIL COUNTY MARYLAND RESPONDS MEMBERSHIP DRIVE

The Cecil County Health Department was in northeast Maryland for a community event held by Cecil College on August 28.

Cecil County unit administrator Jerry Truitt held a membership drive for Maryland Responds using materials from the newly branded recruitment kit. Jerry serves as both the Maryland Responds local unit administrator for Cecil County as well as the health department's emergency preparedness coordinator.

Sixty bags were passed out with emergency preparedness information, health department program information, a 52-piece first aid kit,

plus information about Maryland Responds and how to join.

The Cecil County unit had the opportunity to speak to many college students, school staff, and visitors about types of volunteer opportunities with Maryland Responds. Many were not aware that this was a statewide program that is part of a nationwide system of volunteers.

## GRANT HELPS STATE EXPAND WAREHOUSE SPACE AND ELIMINATE EXPIRED MEDICATIONS

The Maryland Department of Health and Mental Hygiene (DHMH) Strategic National Stockpile Program relies on many critical partnerships to provide medical countermeasures to the public during times of widespread public health emergencies. The Maryland Board of Pharmacy (MD BOP) is one such partner.

Through its Emergency Preparedness Taskforce, the MD BOP provides pharmacist volunteers and state representatives who promote DHMH's efficient medical warehousing operations.

The MD BOP has also provided DHMH with a grant for the disposal of 55,600 pounds of expired prescription medications in Fiscal Year 2015. This process will be completed in Fiscal Year 2016 through an additional grant from the MD BOP.

Thanks to this partnership, the Maryland Strategic National Stockpile Program will have additional warehouse space and ensure that no expired medications are present in the warehouse.

Emergency management, public health, and CERT agencies from the lower four Eastern Shore counties participated in Shorebirds Annual Emergency Preparedness Night on August 29 at the Perdue Stadium in Salisbury, Maryland.

Representatives from the participating agencies set up display tables and engaged attendees. Participants were treated to playing games for prizes and multiple educational brochures, handouts, and tools to assist them in becoming better prepared citizens during all types of disasters and emergencies.

At the Somerset County Health Department booth, participants rolled dice for a chance to win an emergency preparedness bag. The gift bag included items such as: instructions on making emergency kits for people and pets, pencils, crayons, coloring books,

stickers, book marks, carbon monoxide handouts, a carbon monoxide detector complements of the Princess Anne Fire Department, and more! Attendees also played a dice game that tested their emergency preparedness trivia knowledge.

Wicomico County Health Department also provided a spin-the-wheel game which drew in people of all ages from the 3,600 attendees.

Worcester County Health Department provided multiple crowd-pleasing giveaways and focused on recruitment for Maryland Responds. Dorchester County Health Department distributed handouts for all ages including coloring books, pamphlets, and checklists in addition to plastic bags with a checklist printed on the bag.

## AUTUMN CHARGE EXERCISE

### \*\*\*THIS IS AN EXERCISE\*\*\*

This is the text that you will see at the beginning and ending of all communications related to the Autumn Charge Exercise.

On Wednesday, October 7, 2015, beginning at 1 p.m. and ending Thursday, October 8, 2015, at 1 p.m., Maryland Responds unit administrators will participate in a multi-state, coast-to-coast ESAR-VHP and MRC drill that will evaluate the use of the Maryland Responds Registry during a simulated disaster.

During the exercise, you may be contacted by your Maryland Responds unit administrator to participate in the exercise via email, phone, or internal messaging through the Maryland Responds Registry. All exercise communications will start and end with the statement: **"THIS IS AN EXERCISE."**

If contacted, you may be asked for your availability for the exercise deployment period. Please respond to the availability request as if the emergency were real. **You will not be expected to deploy.**

### Your Participation is Vital

This exercise will assist in assessing how many Maryland Responders may be able to deploy in a real world emergency. It also give your unit administrators an opportunity to practice utilizing the Registry's notification and activation systems. So when you see:

please respond as instructed to help us ensure we are ready for the real thing.


## FREE CPR/AED/FIRST AID CERTIFICATION COMING SOON!

When an emergency strikes, will you be ready to save a life? Early CPR is an integral part of providing lifesaving aid to people suffering sudden cardiac arrest. CPR helps to circulate oxygen-rich blood to the brain.

Upcoming CPR/AED offerings will be open to Maryland Responders free of charge. Trainings will be held around the state. Dates

and specific locations are being coordinated. Once final details are scheduled, information will be disseminated through the Maryland Responds Registry and posted on our website.

## RADIATION EMERGENCY MEDICAL MANAGEMENT (REMM)

The "Radiation Emergency Medical Management" app is a valuable reference for those who may have to deal with individuals either suspected or actually exposed to radiation. The app provides guidance for health care providers about clinical diagnosis and treatment of radiation injury during radiological and nuclear emergencies.

The online Web-based and mobile smartphone applications were developed by the Department

of Health and Human Services, Office of the Assistant Secretary for Preparedness and Response (HHS/ASPR), the National Library of Medicine (NLM), the National Cancer Institute (NCI), and the Centers for Disease Control and Prevention (CDC).

## MARYLAND RESPONDS MRC NETWORK IDENTITY EXPLAINED

We recently launched the new statewide identity for the Maryland Responds Medical Reserve Corps (MRC) Network. The Maryland Responds MRC Network identity is a system of key messages and visual communications, graphically coordinated in such a way that the public easily identifies the Maryland Responds MRC Network, its constituent parts and its activities.

A clear and consistent identity is key to maintaining a strong image for the Maryland Responds MRC Network. This consistency also associates Maryland Responds with its brand values of community service, action, resourcefulness and teamwork. It also will help reinforce a consistent image and message about the MRC, both state- and nation-wide.

There are several core elements that form the foundation of the Maryland Responds MRC Network identity and contribute to the development of a strong brand. Core elements include the logo, standard terminology and key messages.

As part of this new era, Responder Status indicates your readiness to deploy with the Maryland Responds MRC on a disaster response or public health mission. The Road to Readiness checklist guides new members through the initial process of becoming a Ready Responder. Once all steps are completed, you have reached Ready Responder status which means that you are eligible for deployment.


